# Minor Athlete Abuse Prevention Policy (MAAPP)

Aquatic Foundation of Alaska (AFA) **Effective Date:** September 1, 2021 **Approved By:** AFA Board of Directors Last Reviewed: October 10, 2025

### This Policy Applies To

**In-Program Contact:** Any contact (including communications, interactions, or activities) between an Adult Participant and any Minor Athlete(s) related to participation in sport.

Examples include, but are not limited to: competition, practices, camps/clinics, training or instructional sessions, pre/post-event meals or outings, team travel, video review, team or sportrelated team-building activities, celebrations, award ceremonies, banquets, team- or sport-related fundraising or community service, sport education, competition site visits, conventions, and/or summits.

#### **Adult Participants**

Any adult 18 years of age or older who is:

- A USA Swimming member, either athlete or non-athlete;
- A participating non-member (e.g., meet marshals, computer operators, timers, etc.);
- Authorized, approved, or appointed by USA Swimming, Zones, LSCs, or member clubs to have regular contact with or authority over Minor Athletes; and/or
- Within the governance or disciplinary jurisdiction of USA Swimming, Zones, LSCs, or member clubs.

# **General Requirement**

USA Swimming, Zones, LSCs, and member clubs are required to implement this Minor Athlete Abuse Prevention Policy (MAAPP) in full.

The MAAPP must be reviewed and agreed to in writing **annually** by all athletes, parents/guardians, coaches, and other non-athlete members of AFA, with written acknowledgment retained by the club.

#### **Definitions**

Key definitions (consistent with USA Swimming MAAPP 2.0) include:

- Athlete: A USA Swimming athlete member.
- **Authority:** A position over another that allows one to direct, control, or make decisions for that person.
- **Dual Relationship:** When an Adult Participant also has a non-sport relationship with a Minor Athlete (family member, teacher, health professional, etc.).
- **Emergency Circumstances:** Serious, unexpected situations that require immediate action and cannot be avoided.
- **Electronic Communication:** Includes phone, email, video, text, or social media.
- **In-Program:** Any activity related to AFA or USA Swimming participation.
- **In-Program Contact / Travel / Massage:** Any such activities involving Adult Participants and Minor Athletes.
- **Minor Athlete:** Any USA Swimming athlete member under 18 years of age or who was a member within the past 12 months.
- **Organization:** Aquatic Foundation of Alaska (AFA).

# **Exceptions**

#### **Close-In-Age Exception**

In-Program Contact between an Adult Participant and a Minor Athlete is permitted if:

- 1. The Adult Participant has **no authority** over the Minor Athlete; and
- 2. The Adult Participant is **not more than four years older** than the Minor Athlete.

#### **Dual Relationship Exception**

An Adult Participant with a dual role or relationship with a Minor Athlete must have **written parental consent** at least annually.

### **One-on-One Interactions**

All one-on-one In-Program Contact between a Minor Athlete and an Adult Participant must be **observable and interruptible** by another adult, except in emergency circumstances or when the above exceptions apply.

#### **Meetings & Individual Training Sessions**

 Meetings must be observable, interruptible, and held in unlocked rooms with open windows or doors.

- Meetings must not occur in hotel rooms or overnight lodging.
- Individual training sessions must be observable and interruptible and require **advance written parental consent**, renewed annually.
- Parents/guardians must be allowed to observe.

#### **Electronic Communications**

All electronic communication from Adult Participants to Minor Athletes must be **professional**, **open**, **and transparent**.

- Parents/guardians must be copied on any one-on-one electronic communication.
- Electronic communication should occur between 5:00 a.m. and 9:00 p.m. local time unless in emergency circumstances or travel.
- Adult Participants may not maintain private social media connections with Minor Athletes.
- Parents may request in writing that their Minor Athlete not be contacted via electronic means; AFA must honor such requests.

### **In-Program Travel and Lodging**

#### Transportation

- Adult Participants must not transport a Minor Athlete one-on-one, except in emergencies or with annual written parental consent.
- Shared or carpool travel should be structured so that **parent/guardians pick up their Minor Athlete first and drop them off last**.
- All traveling Adult Participants must be **USA Swimming non-athlete members**.

#### Lodging

- Adult Participants must not share overnight lodging or sleeping arrangements with athletes.
- All interactions in lodging areas must be **observable and interruptible**.
- Room checks require **two-deep leadership** (two Adult Participants present).
- Minor Athletes should be roomed with others of same competition category and similar age.
- Written consent from a parent/guardian is required annually for all In-Program Travel.

# **Locker Rooms and Changing Areas**

- Deck changing is prohibited.
- All interactions between Adult Participants and Minor Athletes in these areas must be **observable and interruptible**.

- AFA must provide a **private or semi-private changing area** for any Minor Athlete who requests it.
- The use of **recording devices** in these spaces is strictly prohibited.
- Adult Participants must not expose private body parts or request exposure from a Minor Athlete.
- Adult Participants may only shower with Minor Athletes if a **close-in-age exception** applies or it is a pre/post activity rinse in swimwear.
- AFA will monitor locker rooms regularly, using random checks and posted staff supervision.
- Parents entering locker rooms must be of the same competition category and notify a coach or admin beforehand.

### Massages, Rubdowns, and Athletic Training Modalities

- Any In-Program massage must occur in an observable and interruptible space and be performed by a licensed professional.
- Coaches, even if licensed, may not perform massages on athletes.
- Written parental consent is required annually for any massage treatment.
- Parents/guardians must be allowed to observe.
- Minor Athletes must remain **appropriately clothed** at all times.

# **Monitoring and Enforcement**

AFA staff and coaches are required to monitor all team environments — in person, digitally, and during travel — to ensure compliance with MAAPP standards.

Violations will be addressed promptly through:

- 1. Verbal or written notice,
- 2. Investigation by the AFA Safe Sport Coordinator, and
- 3. **Possible disciplinary action**, including suspension or removal from membership.

### **Reporting Concerns**

Any suspected violation, misconduct, or concern must be reported immediately to:

All athletes, parents/guardians, coaches, staff, and volunteers must sign the annual AFA Safe Sport acknowledgment form before participation.
